On the basis of feedback received from Employer about the curriculum of Law College Dehradun 2022-23 we conclude following points:

Academics:

- 1. Regarding the 'Local, National, Regional and Global developmental needs', 33.33% of the employers strongly agreed with it whereas 61.11% agreed with it respectively.
- 2. Regarding the <u>curriculum designed to cater the needs of industry, society and the environment'</u> 11.11% strongly agreed with it whereas 72.22% agreed with it and 16.67% were neutral.
- 3. Regarding the <u>'enhancement of technical skills as per the industry needs'</u>, 16.67% of the employers strongly agreed with it whereas 72.22% agreed with it and 11.11% were neutral respectively.
- 4. Regarding the 'presence of courses which fulfils the required life skills and leadership qualities', 22.22% of the employers strongly agreed with it whereas 61.11 agreed with it and 16.67% were neutral respectively.
- 5. Regarding the 'ability to demonstrate, solve problems and think creatively', 22.22% of the employers strongly agreed with it whereas 66.67% agreed with it and 11.11% were neutral respectively.
- 6. Regarding the 'ability to communicate effectively', 11.11% of the employers strongly agreed with it whereas 55.56% agreed with it and 33.33% were neutral respectively.
- 7. Regarding the 'program covers the aspects of employability, higher learning and entrepreneurial attitude', 22.22% of the employers strongly agreed with it whereas 50% agreed with it and 27.76% were neutral respectively.
- 8. Regarding the 'programme makes students ethically & socially responsible professionals', 22.22% of the employers strongly agreed with it whereas 72.22% agreed with it and 5.56% were neutral respectively.
- 9. Regarding the 'ability to use their domain knowledge effectively in their job', 27.78% of the employers strongly agreed with it whereas 55.56% agreed with it and 16.67% were neutral respectively.
- 10. Regarding the 'Holistic development', 22.22% of the employers strongly agreed with it whereas 55.56% agreed with it and 22.22% were neutral respectively.
